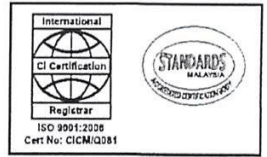

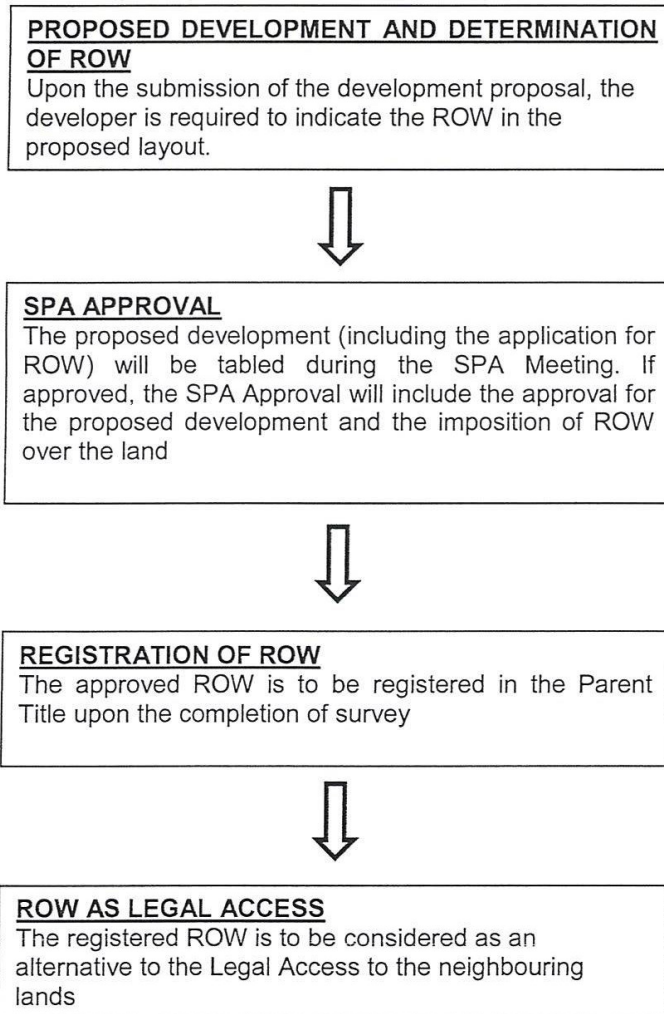
During the previous SPA Meeting, it was agreed that the Right of Way (ROW) will be used as an alternative to Legal Access requirement.

Issues

Previous procedure requires Legal Access to be made available before any development proposal can be considered. Legal Access is a prerequisite to determine whether a particular proposal can be considered or otherwise.

Objective

The purpose of this circular is to facilitate development especially to those owning lands without access to public roads.
