IMPLEMENTATION OF eLOCAL AUTHORITY 2: BUILDING CONTROL SYSTEM (eLA2:BCS)

We refer to the above mentioned matter.

- 2. Please be informed that the Council is proceeding with the implementation of eLocal Authority 2: Building Control System (eLA2:BCS) on the submission of Building and Structural Plans by Qualified Submitting person (QSP) with effect from 1st December 2024.
- 3. The key changes in the procedure of submission through BCS are highlighted below:-
 - The QSP is to submit Building Plan directly to Land & Survey Department and Fire & Rescue Department for endorsement from said departments.
 - 3.2 The QSP is required to furnish a set of the endorsed set from Land & Survey Department and Jabatan Bomba dan Penyelamat to the Council for record.
 - 3.3 The QSP needs to confirm in standard notes that the planning & fire requirements in accordance with endorsed sets are still indicated in the softcopy of Building Plan before uploading to the BCS for submission to the Council.
 - 3.4 Upon no further comment from all departments and/or authorities on the building plans, the QSP needs to submit 3 sets of Building Plan hardcopy for the endorsement by the Council of which 1 set will be returned to QSP.
 - 3.5 The Structural plans, together will all relevant documents is required to be uploaded into BCS where relevant
 - 3.6 All others procedures in BCS are still to be followed.

- 3.7 Requirements on documents to be uploaded:-
 - 3.7.1 All forms are to be signed and uploaded by registered QSP and approved in BCS.
 - 3.7.2 All building plans are to be signed by QSP and owner(s) before upload to BCS.
 - 3.7.3 Consent on scanned signature from the owner(s) in the form of hardcopy with original signature and stamp (if any) shall be submitted together with item 3.4 of this letter.
 - 3.7.4 All photocopied documents such as subdivision plans, planning approval and other as required shall be certified true copy by the QSP before upload to BCS.
- 4. The registration of QSP and submission of Building Plans through BCS can be accessed from the Sarawak Councils website (https://sc.sarawak.gov.my).
- 5. Attached herewith a copy of the revised submission flowchart for your attention please.
- 6. Kindly note that there will be a trial period which will be determined by the Council in due course. If the members have any queries on the revised procedures, please bring the attention of the Council through PAMSC.
